
NOMINATION FOR APPOINTMENT OF MANAGEMENT BOARD MEMBERS FOR CHILD AND YOUTH CARE CENTRE:

REQUEST FOR NOMINATIONS

1. In terms of the provisions of section 208 of the Children’s Act, 38 of 2005 and regulation 84 of the consolidated regulations pertaining to the Children’s Act 2005, relating to the election of the members for the management board, nominations are hereby requested for candidates to be elected by the MEC for Social Development.
2. All nominations must be accompanied by a brief curriculum vitae of the nominee
3. No person with a conflict of interest or a potential conflict of interest may be appointed to the management board.
4. The management board is appointed for a period for a period of 5 years.
5. A nomination must be accompanied by a clearance certificate, to the effect that the nominees name does not appear in part B of the national child protection register or the national register for sex offenders, issued by the Director General and the Director General of justice and Constitutional Development, respectively.
6. Upon receipt of the nominations a short list of not more than 15 members will be submitted to the MEC for Social Development
7. The management board will consist of no fewer than 6 and no more than 9 members.
8. Only candidates who are South African citizens and are resident in the Republic shall be eligible for nomination.
9. Each candidate shall be nominated separately by completing the following:
