#### 1. BACKGROUND

The Department is requesting quotations from Service Providers for the supply, installation and configuration of Wi-Fi technology and data points at Nelson Mandela Metro Office.

#### 2. SCOPE OF WORK

- Submit project plan before commencement of project.
- Supply, Install and configure Wi-Fi technology equipment as per Annexure A.
- Test and label all data points.
- Configure Wi-Fi equipment to form part of existing WIFI cluster.
- Create SSID's that will be provided by department.
- Test Wi-Fi connectivity to departmental systems.
- Supply and Install Uninterrupted power supplies.
- Provide project closeout report with data point test results on completion of project.

The Department has adopted KRONE as its cabling standard; all components of this installation must be in full compliance with the Standard. The detailed Bill of Materials and specification for all equipment is listed in Annexure B.

### 3. PRICING

- 3.1 Service Providers must quote per laptop and give the brand name that they have quoted for as indicated in the attached pricing schedule (Annexure A).
- 3.2 Prices must be inclusive of VAT. If not confirmed, the Department will assume that the price quoted is inclusive of VAT. The Department does not pay VAT to service providers that are not registered with SARS as VAT vendors. It is compulsory for bidders with taxable supplies exceeding R1,000,000.00 (excluding VAT) in a 12 month period to register for VAT.
