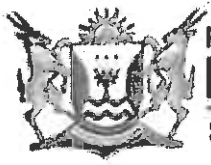

### 3. PRICING

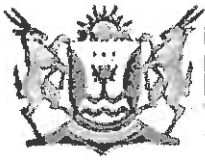
