

# **BID SPECIFICATION DOCUMENT**

SPECIFICATION FOR THE APPOINTMENT OF SERVICE PROVIDER TO REMOVE OFFICE FURNITURE, EQUIPMENT AND DOCUMENTS FROM DUKUMBANA BUILDING GROUND FLOOR; PICK'N'PAY BUILDING GROUND FLOOR IN BHISHO, TO ONE VISION BUILDING IN BHISHO GROUND AND FIRST FLOOR



# 1. BACKGROUND

The Provincial Office of Department of Social Development has acquired new offices at One Vision Building (ERF 5000), next to Office of the Premier.

Currently, some officials are temporarily housed at Dukumbana (ground floor, former ABSA) and Pick'n'Pay office buildings in Bhisho. Hence the movement to the new building in Bhisho, One version.

# 2. OBJECTIVE

The main objective of this bid is to appoint a Service Provider that is registered and specialises in furniture and computer equipment removal, with experience and expertise. The Service Provider must have the basic necessary skills & working tools in order to move office furniture from Dukumbana(Absa), Pick and Pay and One Vision Phase 1 to One Vision Phase 2.

# 3. SCOPE

The furniture and equipment include, but not limited to, computers, printers, switches, servers, sans, desks, boardroom table, chairs, Wall Units, system cupboards and safes.

The successful bidder will be required to:

- 3.1 Dismantle, package and remove office furniture and computer equipment from Dukumbana ground floor (former ABSA), Pick'n'Pay ground floor buildings and One Vision Phase One in Bhisho.
- 3.2 Deliver and assemble office furniture and computer equipment at One Vision Phase Two ground and first floor in Bhisho.
- 3.3 Provide 500 boxes for packaging (53 cm in height, 44 wide, cardboard 7mm thick).
- 3.4 Provide bubble wraps and blankets.
- 3.5 Provide clear packaging Sellotape (48mm width, 50m roll) about 100.
- 3.6 Provide black permanent markers 20.
- 3.7 Wrap any delicate equipment with bubble plastic and pack them safely in boxes.

# 4. DELIVERY PERIOD

The work must be completed within 6 (six)days, including Saturday, after receiving an official order.



### 5. COMPULSORY SITE VISIT

Bidders are required to attend a compulsory site visit at One Vision (Erf 5000) Building next to Office of Premier in Bhisho. Date and times are indicated in the RFQ notice.

# 6. PRICES

- 6.1 Service Providers must complete the quotation and sign the attached pricing schedule (Annexure A).
- 6.2 Prices must be inclusive of VAT. If not confirmed, the Department will assume that the price quoted is inclusive of VAT. The Department does not pay VAT to service providers that are not registered with SARS as VAT vendors. It is compulsory for bidders with taxable supplies exceeding R1,000,000.00 (excluding VAT) in a 12-month period to register for VAT.
- 6.3 Bidders must ensure that there are no errors in the prices quoted.
- 6.4 The quotes should include all activities/services that will be required for the required services as no variations will be accepted unless mutually agreed to by Department and the appointed service provider prior to contract acceptance.
- 6.5 Service providers will carry the responsibility of ensuring that the proposals submitted have been signed by a dully authorized person. Should it be established after the submission of proposals that the signatory authorizing the proposal is not legally appointed by the service provider, the offer/proposal will be disqualified from the evaluation process.
- 6.6 All prices submitted should be written in black ink. No proposals written in pencil will be accepted or evaluated

# **7. PAYMENT**

- 7.1 The successful bidder will bill the Department after all the goods have been removed and delivered according to the scope of work above.
- 7.2 Payment will be made within 30 days of submission of a properly completed invoice.

# 8. SPECIAL CONDITIONS

- 8.1 Bidder must have the basic working tools (Cordless Drills, Screw drivers, Alien Keys, Screws, and protective clothing in the form of two piece overall, boots and hand gloves for all labour employed on site, etc) at the start of this project.
- 8.2 Bidder must have minimum of 4 a ton truck with open at back and be clean.
- 8.3 Bidder must have eight staff with one supervisor for the period of the whole process of relocation.
- 8.4 The department shall be entitled to cancel the order/contract should delivery not take place within the stipulated time frame.



- 8.5 The department shall be entitled to cancel the order/contract should if the basic working tools are not available at the start of the project.
- 8.6 The bidder must have previously completed at least two (2) projects in movement of office furniture, office equipment and records/documents. (Provide refence letter/s in the previous client's letterhead with corresponding order/s)
- 8.7 Bidders must be registered in the Central Supplier Database (CSD). If not registered, bidders must ensure that they are registered before submission of their quotations. Supplier registration may be performed online at the National Treasury's website, www.treasury.gov.za. The Department will not award a contract to a bidder that is not registered on the CSD.

# 9. LOCAL ECONOMIC DEVELOPMENT

To support Local Economic Development within the Province, the department allocated points to be acquired by service providers that are based in the Eastern Cape Province, in line with the Preferential Procurement Regulations 2022.

- 9.2.1 In order to obtain preference points for specific goals, bidders must complete ECBD 6.1.
- 9.2.2 Locality will be confirmed as follows:



- a. The preferred address on CSD is the only address to be considered provided the address was updated on CSD on date prior to the invitation to bid was published.
- b. If the preferred address on CSD was updated on a date after publication of the invitation to bid, then the address registered on CIPC will used as the only address to consider for awarding of locality points.
- c. A lease agreement where offices are lease together with evidence (Bank statement) that rental has been paid for at least 3 months prior to the invitation to bid was published.

- 9.2.3 In order to be awarded points for disability, a doctor's confirmation must be submitted together with this bid.

# 11. BID POLICIES, PROCEDURES AND CONDITIONS:

- 10.1 Quotations are valid for 60 days.
- 10.2 Bidders must be registered in the Central Supplier Database (CSD). If not registered, bidders must ensure that they are registered before submission of their quotations. Supplier registration may be performed online at the National Treasury's website, www.treasury.gov.za. The Department will not award a contract to a bidder that is not registered on the CSD.
- 10.3 Service Providers must complete the preferential points claim forms (SBD 6.1) in order to claim preference points. Service Providers who have completed (SBD 6.1) will not be eliminated but will not qualify for rating points.
- 10.4 The Department reserves a right to verify the validity of the Tax Clearance Certificate before the signing of the contract and shall be entitled to cancel the contract in the event that the service providers Tax Affairs not being in order and or the service provider not having made suitable arrangements with SARS to settle outstanding tax obligations.
- 10.5 The Department may, if necessary, negotiate a market related price.
- 10.6 The Department reserves the right not to award a bid to a bidder that has failed to perform in a contract previously awarded to it by the Department.
- 10.7 This RFQ is subject to the Preferential Procurement Policy Framework Act 2000 and the Preferential Procurement Regulations, 2022, the General Conditions Of Contract (GCC) and, if applicable, any other legislation or special conditions of contract.
- 10.8 Service providers must submit, on a company letterhead, a resolution stating the official with authority to sign on behalf of the company.

# 12. CONSORTIUM / JOINT VENTURE

It is recognized that bidders may wish to form consortia to provide the Services. A bid, in response to this invitation to bid, by a consortium must comply with the following requirements: -

- 11.1 Copy of agreement signed by all the members must be submitted. One of the members must be nominated as authorized to be the lead member and this authorization shall be included in the agreement entered into between the consortium members. The lead member must be the only authorized party to make legal statements, communicate with the Department and receive instructions for and on behalf of any and all the members of the Consortium;
- 11.2 All parties must be registered on CSD;
