## 1. BACKGROUND

A merger between John X Merriman and Bhishe CYCC is currently underway. John X Merriman is a secure care facility for children awaiting trial. Bhishe Child and Youth Care Centre is also a security care facility where children in conflict with the law are kept, however, the centre is currently underutilized.

John X-Merriman CYCC's state of non-compliance with National Minimum Norms and standards and Blueprint minimum norms and standards for secure care necessitated the approval by the HOD to close the centre.

The Department is currently incurring costs for cleaning, catering and security services in both facilities. Thus, the merger is a cost-effective option, as costs for services will be provided in one facility instead of being split between the two as is currently the case.

The merger therefore seeks to ensure optimal utilization of Bhishe Child and Youth Care Centre.

John X Merriman CYCC has a staff complement of 74 employees in total. They will move to Bhishe CYCC as their new place of work and these employees are entitled to resettlement benefits, as this is an employer-initiated transfer.

The Department is looking for a service suitable service provider to arrange the service as detailed from the scope of work below in Bhishe/King William's Town area.
