1. BACKGROUND

A merger between John X Merriman and Bhisho CYCC is currently underway. John X Merriman is a secure care facility for children awaiting trial. Bisho Child and Youth Care Centre is also a security care facility where children in conflict with the law are kept, however, the centre is currently underutilized.

John X-Merriman CYCC's state of non-compliance with National Minimum Norms and standards and Blueprint minimum norms and standards for secure care necessitated the approval by the HOD to close the centre.

The Department is currently incurring costs for cleaning, catering and security services in both facilities. Thus, the merger is a cost-effective option, as costs for services will be provided in one facility instead of being split between the two as is currently the case.

The merger therefore seeks to ensure optimal utilization of Bisho Child and Youth Care Centre.

John X Merriman CYCC has a staff compliment of 74 employees in total. They will move to Bhisho CYCC as their new place of work and these employees are entitled to resettlement benefits, as this is an employer-initiated transfer.

The Department is looking for a service suitable service provider to arrange the service as detailed from the scope of work below in Bhisho/King William's Town area.

- ii) The preference points claimed are in accordance with the General Conditions as indicated in paragraph 1 of this form;
- iii) In the event of a contract being awarded as a result of points claimed as shown in paragraphs 1.4 and 4.2, the contractor may be required to furnish documentary proof to the satisfaction of the organ of state that the claims are correct;
- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
 - (a) disqualify the person from the tendering process;
 - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
