## **SPECIFICATION FOR APPOINTMENT OF A SERVICE PROVIDER TO ARRANGE CAR RENTAL FOR THE 7 DISTRICT OFFICE (INCLUDING ALFRED NZO, AMATHOLE, BCM, CHRIS HANI, JOE GQABI, NMM AND OR TAMBO) OFFICIALS**

### **1. BACKGROUND**

The Department of Social Department in the Eastern Cape (DSD) wishes to appoint a suitable qualified and experienced service provider to arrange car rental for 7 Districts. The vehicle to be driven both in rural and urban areas of the Eastern Cape Province.

### **2. SCOPE OF WORK:**

1. The successful bidder will be expected to arrange car rental for the Districts as indicated below:
  - a) 14 Double Cab Bakkies (2 per district) with Canopies, 4x4 Diesel with engine capacity between 2 and 2.5 litre.
  - b) Fuel Cards
  - c) Full comprehensive insurance cover with excess waiver.
  - d) Replacement vehicle (Same category) in the event of the hired vehicle having broken down or involved in an accident.
  - e) The vehicles must be available as and when required within a period of 3 days on request.

### **3. CONTRACT PERIOD**

The contract will be for a period of one month. The vehicles may not be required on a daily basis throughout the contract period and that should be taken into consideration when invoicing.

### **4. COMPETENCIES AND EXPERTISE REQUIRED**

The successful bidder must:

3.1 Bidder must have previously completed at two projects of this nature.

## 5. PRICING

- 4.1 Bidders must submit quotations which include all the costs for the service. (complete Annexure A).
- 4.2 Prices must be inclusive of VAT. If not confirmed, the Department will assume that the price quoted is inclusive of VAT. The Department does not pay VAT to service providers that are not registered with SARS as VAT vendors. It is compulsory for bidders with taxable supplies exceeding R1,000,000.00 (excluding VAT) in a 12 month period to register for VAT.
- 4.3 Bidders must ensure that the quotes submitted have no arithmetic errors as department will not rectify any errors on the quotations received. The quotes should include all the necessary activities/services to complete the project as no variations will be accepted unless mutually agreed to by department and the appointed service provider prior to contract acceptance.
- 4.4 Bidders will carry the responsibility of ensuring that the proposals submitted have been signed by a dully authorised person. Should it be established after the submission of proposals that the signatory authorising the proposal is not legally appointed by the service provider, the offer/proposal will be disqualified from the evaluation process.
- 4.5 All prices submitted should be typed or handwritten in black ink. No proposals written in pencil will be accepted or evaluated.

## 6. PAYMENT

- 5.1 The successful bidder will bill the Department after services have been completely rendered.
- 5.2 Payment will be made within 30 days of submission of a properly completed invoice.

## 7. LOCAL ECONOMIC DEVELOPMENT

To support Local Economic Development within the Province, preference will be given to service providers who have established their offices located in the Eastern Cape. The application of preference is clearly specified on Stage 3 of evaluation.

## 8. SPECIAL CONDITIONS

- 7.1 The successful bidder will ensure compliance with all the applicable regulations in the performance of this service.
- 7.2 Bidders must be registered in the Central Supplier Database (CSD). If not registered, bidders must ensure that they are registered before submission of their quotations. Supplier registration may be performed online at the National Treasury's website, [www.treasury.gov.za](http://www.treasury.gov.za). The Department will not award a contract to a bidder that is not registered on the CSD.
- 7.3 Hiring of Double Cab Bakkies with Canopy Including Fuel Cards for 7 district offices (2 per district).
- 7.4 **The vehicle must be available for collection or be delivered at the town where the department's district office is located.**

## 9. Evaluation Criteria:

### 8.1 Stage1: Pre-qualification criteria

- 8.1.1 Quotation is only valid when signed by the service provider.
- 8.1.2 Correction fluid of any kind **MUST NOT** be used. Any corrections made on PRICE must be made by drawing a line across the incorrect statement, writing in the correct details above the same and subsequently endorsing the entry with the bidder's signature.
- 8.1.3 Fully completed and signed SBD4
- 8.1.4 Fully completed Annexure A and B
- 8.1.5 Provide minimum of two contactable references on similar work done. (Complete annexure B)

**N.B: Failure to fully comply with the pre-qualification criteria will lead to the automatic disqualification of Request for Quotation (RFQ).**

### 8.2 Stage 2: Evaluation on PPPFA

Quotation will be evaluated on the 80/20 preference point system, as contemplated in the Preferential Procurement Policy Framework Act (Act 5 of 2000). Quotations will be evaluated on price and specific goals. Service Providers are required to submit together with their quotations original and valid B-BBEE status level verification certificates or certified copies thereof to substantiate their B-BBEE rating claims. A trust, consortium or joint venture must submit a consolidated B-BBEE Status Level Verification. Service Providers who do not submit valid B-BBEE status level verification certificates will not qualify for preference points.

- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
