He was therefore placed in foster care with a relative in the Western Cape who was attacked and passed away while she was out at night to look for Liyabona who was reported to be on the street with friends.**

IF YOU OR ANY PERSON KNOWN TO YOU may be familiar with or known to the child, kindly contact the above mentioned designated social worker or the nearest police station.
