IF YOU OR ANY PERSON KNOWN TO YOU may be familiar with or known to the child, kindly contact the above designated social worker or the nearest police station.

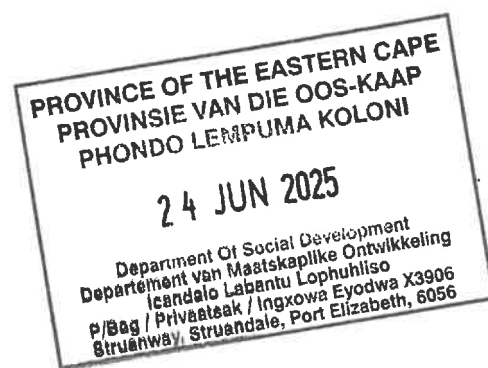
