Service Specification: HIV & AIDS 2025/2026 – 2027/ 2028

1. INTRODUCTION

Home Community Based Care (HCBC) is the provision of comprehensive health and social services by community care givers to beneficiaries in order to promote, restore, and maintain the quality of life on an individual, a family, and a community. It is a well-established approach supported by Government to mitigate the socio-economic impact of HIV and AIDS at community level. By its very nature it is rooted in the practice of PSS to people living with HIV and AIDS. Through the Programme, individuals, families and communities are enabled to have access to services closest to home. HCBC Programme promotes active participation of all target groups. It also serves as an entry point into other services, especially at Prevention and early intervention levels.

The 2019 Survey reflected that HIV prevalence among pregnant women has remained largely unchanged at around 30% since 2004. The consistent decline in HIV prevalence among young women (15–24 years) is encouraging as this age group experiences a high rate of HIV incidence (1.5%) compared to their male counterparts (0.5%). The high PMTCT ART coverage regardless of age group shows the success of the PMTCT programme. Promising progress has been observed in the number of HIV positive women initiating ART before pregnancy, although young women (15–24 years) were still less likely to know their HIV-positive status before pregnancy compared to older women (>35 years).

Despite free contraceptive services provided in public health facilities in the Eastern Cape Province, the prevalence of unintended pregnancy is very high in Alfred Nzo and OR Tambo districts. In collaboration with the Departments of Basic Education, Higher Education and Social Development, strategies to strengthen school based sexual and reproductive health education were developed to address the dual burden of HIV, sexually transmitted diseases and unplanned pregnancy among adolescent girls and young women.

The Department of Social Development will be funding NPO's as it's contribution to reduction of risky behaviour leading to HIV infection and teenage pregnancy in the next coming Multi Year Funding cycle.

2. STRATEGY FOR INTERVENTION

- In response to HIV and AIDS, Department of Social Development (DSD) derives its mandate from the National Strategic Plan (NSP) for HIV / AIDS and TB 2023 - 2028 which acknowledges that HIV and AIDS is not only a health issue, but a developmental issue, hence the Combination approach.
- The 5th National Strategic Plan (NSP), 2023-2028 outlines key prevention strategies aimed at accelerating **a** reduction in the burden of HIV, TB, STI (Sexually Transmitted Infections) and GBV prevention and care.
- The provision of HIV prevention and treatment education is listed as the key intervention carried out through mass and social media whilst acknowledging and incorporating health literacy, health rights and responsibilities.
- Emphasis in the 5th NSP is on enhancement of tailored messaging to improve HIV, TB, and STI treatment.

3. OBJECTIVES OF 2025/2026 FUNDING

- The mandate of the Department is to reduce the socio-economic impact of HIV and AIDS, STI's and TB by implementing preventative and community-based care Programmes for Children, Youth and Families infected and affected by HIV and AIDS.
- More focus will be on Prevention Programmes focusing on Youth Aged 15-24 Years in the Year 2025-28 with a view to strengthen social and behavior change as well as Psychosocial Support services.
