CORROBORATIVE EVIDENCE	Corroborative evidence is Portfolio of Evidence that support variance explanations stated in the performance reports in the event of over / under performance.
ALIGNMENT	These Standard measures alignment of reported information to the Primary Source Data that is kept at the Service office level, Approved Annual Performance Plan Performance Indicators and Operational Plan Monthly Activities across all levels of the Department.
NARRATIVE ACHIEVEMENTS	Narrative achievements are data that must include the following elements:  I. Quantitative and qualitative information on implemented Programmes or interventions II. Immediate results of each intervention and Programme implemented III. Expected Benefits of Reported Performance linked to National Priorities IV. Where were the interventions implemented (geographic location namely, district municipality or local municipality including relevant specific wards form the relevant 39 poorest wards of the province as per the Provincial Development Plan) V. Who are the beneficiaries? (Disaggregate beneficiaries by gender, women, youth, children, people with disabilities)
RECOVERY PLANS	These standard measures development and monitoring of Recovery plans for all areas of underperformances at all levels (NPO, Service Office, Area Office, District and Provincial Offices).
ACCESSIBILITY	These standard measures the ease with which information can be retrieved and Departmental performance information filing standards must be adhered to.
