## 1. BACKGROUND

The Eastern Cape Department of Social Development is currently using the VEEAM solution for Backup and Replication of Departmental data. The software is currently installed to backup server workloads located in both Bhisho and King William's Town data centres and to replicate these workloads to the Disaster Recovery site in East London Data centre. The current Veeam license and support contract expired in January 2019 hence the request for proposals to renew.

## 2. OBJECTIVE

The main objective of this bid specification is to appoint a service provider that will provide the renewal of Veeam licenses, configuration of backups and replications as well as support and maintenance as described in the scope of work below.

## 3. SCOPE OF WORK

Bidders are required to

- a) Renew the 16 CPU licenses with VEEAM Availability Suite
- b) Upgrade Veeam to the latest version.
- c) Ensure that the configured Backups and Replications run on success (including the errors that might be in) in 3 Data Centres, enable the configuration for monitoring, reporting and capacity planning functionality for (KWT) to connect with Bhisho / East London site, Bisho to work with East London site.
- d) Configure Surebackup jobs.
- e) Configure proxy servers to be on virtual.
- f) Test results should run for three (3) weeks to deem success before sign off.
- g) Detailed Build As document to be provided on project sign off.
- h) Arrange for VEEAM Backup and Replication Software onsite training for technical configuration and monitoring.
- i) Provide technical support for 3 months after sign off.

## 4. CONTRACT AND DELIVERY PERIOD

This contract should provide for the allocation of license renewal, configuration, maintenance and support for the period of one (1) year. The successful bidder will deliver the services within 5 working days after the receipt of an official order.

## 5. PRICES

- 5.1 Service Providers must quote for licensing per license category as indicated in the attached pricing schedule (Annexure A).
- 5.2 Prices must be inclusive of VAT. If not confirmed, the Department will assume that the price quoted is inclusive of VAT. The Department does not pay VAT to service providers that are not registered with SARS as VAT vendors. It is compulsory for bidders with taxable supplies exceeding R1,000,000.00 (excluding VAT) in a 12 month period to register for VAT.

## 6. PAYMENT


- 6.1 The successful bidder will bill the Department based on the milestones completed as per the agreed project implementation plan.
- 6.2 Payment will be made within 30 days of submission of a properly completed invoice.

## 7. SPECIAL CONDITIONS

- 7.1 Bidders must provide professional licenses with VEEAM Availability Suite for a period of one year.
- 7.2 Bidders must provide a letter confirming the service provider as a Veeam Backup and Replication solution reseller.
- 7.3 Preference will be given to service providers who are based within the Eastern Cape Province. Provide proof of address (locality).
- 7.4 The Department requires the implementation of the product to be done by an Engineer trained on the Veeam solution. A Veeam training certificate must be provided. Should the assigned engineer be unavailable during the contract period, a replacement must be provided within 5 working days.
- 7.5 The requirements outlined in the scope must be met by a single solution managed in a single console, not multiple solutions sold together.
- 7.6 Bidders must provide contactable references where they have done similar work.
- 7.7 All prices must be South African Rand based and must not be subject to exchange rate fluctuations.
- 7.8 Bidders must be registered in the Central Supplier Database (CSD). If not registered, bidders must ensure that they are registered before submission of their quotations. Supplier registration may be performed online at the National Treasury's website, [www.treasury.gov.za](http://www.treasury.gov.za). The Department will not award a contract to a bidder that is not registered on the CSD.
- 7.9 Correction fluids of any kind **MUST NOT** be used when completing the document. In cases where corrections are necessary **ON PRICE**; these can be made by crossing a line on the incorrect statement, writing in the correct details above the same and subsequently endorsing the entry with the bidder's signature.

## 9. EVALUATION

The bid will be evaluated in two phases, pre-evaluation and evaluation as per Preferential Procurement Framework Act 5 of 2000 (PPPFA) as Indicated below:

### 9.1 PRE-EVALUATION CRITERIA

- 9.1.1 Registration in the Central Supplier Database (CSD).
- 9.1.2 Quotation is only valid when signed by the service provider.
- 9.1.3 Copy of signed agreement in the case of Joint Venture / Consortium clearly indicating roles and responsibilities in accordance with conditions stipulated in paragraph 10.1.
- 9.1.4 Fully completed and signed Annexure A & B (Indicate with "N/A" when information is not applicable).

## 9.2 EVALUATION AS PER PPPFA

Bid proposals will be evaluated in accordance with the 80/20-preference point system, as contemplated in the Preferential Procurement Policy Framework Act (Act 5 of 2000). Bids will be evaluated on price and specific goals. Bidders are required to submit together with their bids original and valid B-BBEE status level verification certificates or certified copies thereof to substantiate their B-BBEE rating claims. A trust, consortium or joint venture must submit a consolidated B-BBEE Status Level Verification. Bidders who do not submit valid B-BBEE status level verification certificates will not qualify for preference points.

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
