8.2.3 In order to be awarded points for no franchise (black ownership), the bidder must have had no franchise prior to the introduction of the 1983 and 1993 Constitutions.

8.2.4 In order to be awarded points for disability, a doctor's confirmation must be submitted together with this bid.

8.2.5 In cases where the shareholder who qualifies for preference points owns less than 100% shares, points will be allocated in proportion to the percentage of ownership.
