**SPECIFICATION FOR THE APPOINTMENT OF SERVICE PROVIDER TO SUPPLY AND DELIVER FOOD
PARCELS AT TLOKOENG AND NQANQARHU SERVICE DELIVERY POINTS**

1. BACKGROUND

The provision of Social Relief Services to the poor, the vulnerable and the marginalised in the Eastern Cape is the responsibility and compelling mandate of the Department of Social Development. It is designed to promote an efficient and equitable spread of food relief, taking into consideration the unique needs of beneficiary households including coping capabilities, survival and livelihood status of each intended beneficiary household.

2. OBJECTIVE

The main objective is to secure services of a suitable service provider to supply and delivery goods to identified beneficiary household, through the provision of pre-packed food parcels to affected families within at Nqanqarhu and Tlokoeng . Successful Service Provider will be required to delivery 50 food parcels at Nqanqarhu and 40 food parcels at Tlokoeng

3. SCOPE OF WORK EXPECTED FROM THE SERVICE PROVIDER

The successful bidder is expected to:

- Supply and deliver 50 food parcels at Nqanqarhu and 40 food parcels at Tlokoeng
- Delivery must be made between 08H00 and 15H30 to enable officials to check the contents in terms of the official purchase order. Delivery made after the set hours will not be accepted unless prior arrangement has been made with the Department. It is the responsibility of the appointed service provider to load and off – load the food parcels.

4. DELIVERY PERIOD

Delivery must be made within 15 days after receiving an official order.

5. PRICES

- 5.1 Service Providers must submit quotation by completing the attached pricing schedule (Annexure A)
- 5.2 Prices must be inclusive of VAT. If not confirmed, the Department will assume that the price quoted is inclusive of VAT. The Department does not pay VAT to service providers that are not registered with SARS as VAT vendors. Bidders must take note of the prescribed threshold for compulsory registration for VAT.
- 5.3 Bidders must ensure that there are no errors in the prices quoted.
- 5.4 The quotes should include all activities / services that will be required for the required services as no variation will be accepted unless mutually agreed to by Department and the appointment service provider prior to contract acceptance.

5.5 Service providers will carry the responsibility of ensuring that the proposals submitted have been signed by a duly authorized person. Should it be established after the submission of proposals that the signatory authorizing the proposal is not legally appointed by the service provider, the offer/proposal will be disqualified from the evaluation process.

5.6 All prices submitted should be written in black ink. No proposals written in pencil will be accepted or evaluated

6. PAYMENT

6.1 The successful bidder will bill the Department after all sessions have been delivered.

6.2 Payment will be made within 30 days of submission of a properly completed invoice.

7. SPECIAL CONDITIONS

7.1 Bidders must complete declaration of interest form SBD4.

7.2 Bidders must be registered in the Central Supplier Database (CSD). If not registered, bidders must ensure that they are registered before submission of their quotations. Supplier registration may be performed online at the National Treasury's website, www.treasury.gov.za. The Department will not award a contract to a bidder that is not registered on the CSD.

7.3 Service must be rendered within the stipulated time frame. Failure to deliver within the stipulated time frame will result to the cancellation of the contract.

7.4 All goods must be manufactured in South Africa and be SABS approved.

7.5 Bidders claiming preference points are required to complete and sign the preference points claim forms (i.e. SBD 6.1) in order to be considered for the allocation of preference points.

7.6 All submissions of bids must be deposited in the relevant bid box. No late bids will be considered.

7.7 No tender briefing session is scheduled for this bid. Should bidders seek clarity on any aspect on this bid, the relevant officials indicated in the invitation to bid should be contacted..

8. LOCAL ECONOMIC DEVELOPMENT

To support Local Economic Development within the Province, the department allocated points to be acquired by service providers that are based in the Eastern Cape Province, in line with the Preferential Procurement Regulations 2022.

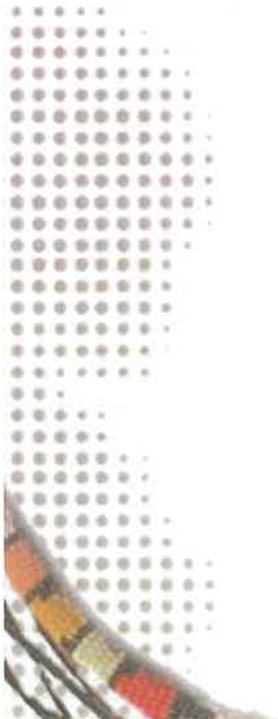

9. EVALUATION

The bid will be evaluated in two phases, pre-evaluation and evaluation as per Preferential Procurement Framework Act 5 of 2022 (PPPFA) as indicated below:

9.1 PRE-EVALUATION CRITERIA

- 9.1.1 Pricing Schedule is only valid when signed by the service provider or person with authority.
- 9.1.2 Copy of signed agreement in the case of Joint Venture / Consortium clearly indicating roles and responsibilities in accordance with conditions stipulated in paragraph 11.1

9.2.1 In order to obtain preference points for specific goals, bidders must complete ECBD 6.1.

9.2.2 Locality will be confirmed as follows:

- a. The preferred address on CSD is the only address to be considered provided the address was updated on CSD on date prior to the invitation to bid was published.
 - b. If the preferred address on CSD was updated on a date after publication of the invitation to bid, then the address registered on CIPC will be used as the only address to consider for awarding of locality points.
 - c. A lease agreement where offices are lease together with evidence (Bank statement) that rental has been paid for at least 3 months prior to the incitation to bid was published.
 - d. Copy of water and lights account from the municipality (Municipal Account, not a councilor's letter) or Eskom statement. The proof of address must be in the name of the company.
 - e. In case of a joint venture, the preferred address on CSD will be considered provided the JV partner has more that 50% interests in the JV,
- *In order to be awarded points for disability, a document confirming permanent disability from a registered medical doctor must be submitted together with this bid.*
 - *In order to be awarded points for no franchise (black ownership), the bidder must have had no franchise prior to the introduction of the 1983 and 1993 Constitutions.*

10. BID POLICIES, PROCEDURES AND CONDITIONS:

10.1 Quotations are valid for 60 days.

10.2 Bidders must be registered in the Central Supplier Database (CSD). If not registered, bidders must ensure that they are registered before submission of their quotations. Supplier registration may be performed online at the National Treasury's website, www.treasury.gov.za. The Department will not award a contract to a bidder that is not registered on the CSD.

- 10.3 Service Providers must complete the preferential points claim forms (SBD 6.1) in order to claim preference points. Service Providers who have completed (SBD 6.1) will not be eliminated but will not qualify for rating points.
- 10.4 The Department reserves a right to verify the validity of the Tax Clearance Certificate before the signing of the contract and shall be entitled to cancel the contract in the event that the service providers Tax Affairs not being in order and or the service provider not having made suitable arrangements with SARS to settle outstanding tax obligations.
- 10.5 The Department may, if necessary, negotiate a market related price.
- 10.6 The Department reserves the right not to award a bid to a bidder that has failed to perform in a contract previously awarded to it by the Department.
- 10.7 This RFQ is subject to the Preferential Procurement Policy Framework Act 2000 and the Preferential Procurement Regulations, 2022, the General Conditions Of Contract (GCC) and, if applicable, any other legislation or special conditions of contract.
- 10.8 Service providers must submit, on a company letterhead, a resolution stating the official with authority to sign on behalf of the company.

It is recognized that bidders may wish to form consortia to provide the Services. A bid, in response to this invitation to bid, by a consortium must comply with the following requirements: -

- 11.1 Copy of agreement signed by all the members must be submitted. One of the members must be nominated as authorized to be the lead member and this authorization shall be included in the agreement entered into between the consortium members. The lead member must be the only authorized party to make legal statements, communicate with the Department and receive instructions for and on behalf of any and all the members of the Consortium.
- 11.2 All parties must be registered on CSD.

- 12.1 Whilst all due care has been taken in connection with the preparation of this RFQ, the Department makes no representations or warranties that the content in this RFQ or any information communicated to or provided to bidders during the Bidding process is, or will be, accurate, current or complete.
