TERMS OF REFERENCE FOR THE APPOINTMENT OF THE SERVICE PROVIDER TO CONDUCT SKILLS AUDIT FOR FORTY (40) SENIOR MANAGEMENT SERVICES (SMS) MEMBERS OF THE DEPARTMENT OF SOCIAL DEVELOPMENT AT PROVINCIAL AND DISTRICT LEVEL FOR THE 2026/2027 FINANCIAL YEAR.

1. INTRODUCTION

The Eastern Cape Provincial Department of Social Development intends to undertake a Skills Audit Project for forty (40) Senior Management Services (SMS) members of the Department. This process is intended to assist the Department to understand the skills / competencies / qualifications that are required for each role, and the actual skills / competencies / qualifications each employee currently possess. In line with the applicable Department of Public Service and Administration (DPSA) framework and mandates it has been established that the SMS members of the Department are complex and professional.

The competencies that appear in the SMS Leadership and Management Competency Framework are viewed as being critical for high performance in the senior manager's role. These competencies are grouped under the Core Generic Leadership and Management Competencies that describe thought processes that influence behaviours and the functional characteristics that represent what needs to be done by SMS members in demonstration of their leadership and managerial roles.

Process Competencies exhibits the most useful externally observed set of behaviours that determine how leaders make successful or poor decisions. The process competencies influence the success of the core competencies. For example, if the standard of the process competencies is low, a manager may not effectively achieve the core competency, and the opposite is true. The achievement therefore depends on connection between the process and the core competencies to yield the required outcome. Personal Attributes / Personal Values cut across both the process and core competencies and complement the Public Service values

Thus, the Department needs to continuously align itself and empower its SMS members with relevant qualifications, skills and competencies to enable them to fulfil their roles.

The Skills Audit will be carried out at Provincial Office and in all the eight (8) Districts of the Department.

2. THE PURPOSE

- 2.1. To contract an external service provider to conduct skills audit for forty (40) Senior Management Services (SMS) members in the Eastern Cape Provincial Department of Social Development Provincial Office and in all the eight (08) Districts of the Department.
- 2.2. To draw up a skills development plan for the 40 SMS members and advise on the implementation of such plan to all Departments.

3. SCOPE OF WORK/ACTIVITIES TO BE UNDERTAKEN

- 3.1. The Eastern Cape Department of Social Development is inviting proposals from reputable service providers in the field of Human Resource Development to conduct skills audit for forty-40 Senior Management Services (SMS) members in the Provincial Office and in all the eight (08) Districts of the Department.
- 3.2. To fulfil / satisfy the contract needs, the service provider should consider the following.
 - 3.2.1. Identification of skills / competencies / qualifications currently existing in Department pertaining to the SMS members related functions, this must be guided by the DPSA framework.
 - 3.2.2. The Skills Auditor will assess the SMS members' existing skills / competency / qualifications levels against the DPSA benchmark on skills and competencies required to perform the SMS related roles / functions.
 - 3.2.3. Upon ascertaining the above, the Skills Auditor will advise whether the SMS members have the appropriate skills / competencies / qualifications to perform the SMS related roles / functions.

3.2.4. The Skills Auditor will then do a needs assessment based on the preliminary findings.

3.2.5. The Skills Auditor will draw up a skills development plan and advise on the implementation of such plan in the Department; this will specifically address the identified gaps in skills and competencies and the challenges they are faced with.

4. METHODOLOGY

4.1 Interested service providers should present a proposal clearly to the Provincial Department of Social Development:

4.1.1. A methodology for conducting the work.

4.1.2. A proposed projectized work plan.

4.1.3. The names and CVs of the individual/s to be assigned to do the work.

4.1.4. An itemized budget and indication of the total cost of the proposed work plan.

5. DELIVERABLES

The Provincial Department of Social Development is expecting the following deliverables:

5.1. Identification of skills / competencies / qualifications currently existing pertaining to officials currently employed as SMS members.

5.2. Assess whether SMS members have the appropriate skills / competencies / qualifications to perform SMS related roles and functions.

5.3. Provide a comprehensive report of the SMS members Skills Audit to the Department.

5.4. The Skills Auditor will do a needs assessment and is expected to draw up a skills development plan for SMS members in the Department, which will specifically address their needs and the challenges they are faced with.

5.5. Transfer skills while executing the Skills Audit project to Departmental Human Resource Development officials at Provincial and District offices.

6. CONDITIONS OF CONTRACT AGREEMENT

- 6.1. **Ownership and publication of deliverables:** The Provincial Department of Social Development will become the owner of all data collected, furnished and/or compiled by the service provider during the project process and for the purposes of executing the contract agreement.
- 6.2. **Publication:** The publication and utilization of the data will be at the discretion of the Department of Social Development.
- 6.3. **Confidentiality:** All information gathered is confidential and its use by the service provider shall be for executing the project as per contract agreement.
- 6.4. The Provincial Department of Social Development will select the best proposal, and it will under no circumstances increase the agreed amount of the consultancy once a contract has been drawn up.

7. SUBMISSION OF PROPOSALS

- 7.1. The closing date for submission of proposals is **indicated in the RFQ notice**.
- 7.2. Proposals must be deposited into the bid box situated at Albertina Sisulu Building, 7 Beatrice Street, King Williams Town.

8. PROPOSALS MUST BE ACCOMPANIED BY:

- 8.1. A company profile
- 8.2. Curriculum vitae of proposed members of the team, illustrating qualifications and experience.
- 8.3. The accreditation certificate by a recognized accrediting body.

9. SPECIAL CONDITIONS

- 9.1 Bidders must be registered in the Central Supplier Database (CSD). If not registered, bidders must ensure that they are registered before submission of their quotations. 11. PRICING

11.1 Bidders must submit a detailed price schedule in respect of all costs and quote as per the pricing schedule attached hereto.

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:
