The current environment is laid out with Aruba switching technologies and these additional switches will form part as an extension of this already existing switching environment.

The Department invites prospective service providers to submit proposals to supply and deliver six (6) 48 port power over ethernet (POE) switches with a 3-year next business day warranty.

2. OBJECTIVE

The main objective of this bid is to appoint a Service Provider who is registered on SITA RFB 2003 transversal contract to supply and deliver six (6) 48 Port switches with a 3-year next business day warranty

3. SCOPE

The bidders must submit proposals to supply and deliver six (6) 48 port power over ethernet (POE) switches as per the minimum specifications provided in Table 1.

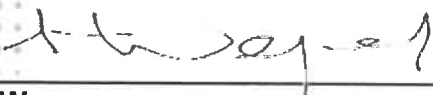

8. EVALUATION
